V. I agree to comply with rules and regulations as posted and as set forth by teachers, instructors, stable owners and counselors.
VI. The risk of injury from the activities involved in this program is significant including the potential for paralysis and death and while particular rules, equipment, and personal discipline may reduce risk, the risk of serious injury does exist.
VII. I knowingly and freely assume all such risks, both known and unknown, and assume full responsibility for my voluntary participation.
VIII. I willingly agree to comply with the stated and customary terms and conditions for participation. If I observe any unusual significant hazard during my presence or participation.

I, for myself and on behalf of my spouse, heirs, assigns, personal representatives and next of kin, hereby release and hold harmless, GG Stables LLC, the host organization and facility, any owners, sponsors, volunteers, employees, agents, officers or directors of the above organizations, and if applicable, owners and lessors of premises used to conduct the event (collectively the "Releasees") with respect to any and all injuries, disabilities, loss of life or damage to person or property occurring or arising out of participation in the program.
